TRAC Meeting Calls For Action

Did you know that another property tax triennial reassessment is scheduled for 2003? On August 26th, TRAC (Tax Reform Action Coalition) held an open forum, co-sponsored by SNA, with our elected officials and candidates at the Mercury Theatre. The purpose of the meeting was two-fold: (1) to gain commitment from our elected officials and candidates to introduce legislation that will alter the tax funding formula, resulting in a more equitable distribution of the tax burden and curtail the states use of the property tax as its primary source of revenue, and (2) to move forward a petition that would limit reassessment increases for residents who have lived in their homes for a certain number of years.

Invited officials and candidates included Mark Augusti, John Cullerton, John Fritchey, Sara Feigenholtz, Mike Weiler, Larry McKeon, Mike Quigley, Forrest Claypool and Ron Messina. Although some differed as to the most effective way to reduce property taxes, all of the invited guests did pledge their support in this effort.

TRAC is looking for people who are interested in helping work toward a solution to rising property taxes. Volunteers do not need to an in-depth understanding of property tax assessments in order to help, since the areas of need are many. TRAC is also looking for someone with experience drafting bills for state officials to present in Springfield. State officials suggested that it would be helpful for TRAC to present them with a written bill which they could present to their peers in the legislature. "One Man Army of Bataan" Grew Up On Janssen

The neighbors who attended the recent House History tours heard many interesting tales, but one was found to be the most intriguing.

An unimposing 1916 brick bungalow at 3631 N. Janssen was the childhood home of Arthur W. Wermuth, Jr. (1915-1981), the son of a local physician. At the outbreak of World War II, Arthur joined the infantry as a Lieutenant and left the Army in 1945 as a much-decorated, and famous, Captain.

During the Battle of Bataan in April 1942 he was wounded, but still able to grab a machine gun and kill over 100 enemy troops. The event was immortalized in comic books of the period, and he was dubbed the "one man army of Bataan". Captured, he spent the war in various prison camps and was witness to one of the darker chapters in Japanese war atrocities.

While being moved with 1600 other P.O.W.'s deeper into Japanese-held territory in January 1945, Capt. Wermuth's ship was torpedoed and the prisoners were left to fend for themselves. Capt. Wermuth, although again wounded, took command of the situation and saved many lives. Of the original 1600, only 300 ultimately survived. Capt. Wermuth was one of them, and when he was liberated in April of that year, he weighed only 103 pounds from his original 190, and was able to describe the atrocities and identify the criminals then brought to justice.

After the war, in April 1951, he gained further notoriety when he became a Wichita, Kansas marshal and captured Scientology founder L. Ron Hubbard in a divorce proceeding, a feat that received nationwide coverage in the newspapers. By 1960 he was sheriff of Jefferson County, Colorado, and was instrumental in capturing the murderer of Adolph Coors III.

SNA Planning & Development's *Did you know?*

Your ability to make improvements or repairs to your home has just been simplified. The Chicago Department of Buildings has opened a Neighborhood Residential Permit Center equipped to assist homeowners in obtaining building permits. The North Side office is located at 2550 West Addison, and can be contacted at 312/742-2560.

The Purpose of A Permit

A building permit gives you, your insurance company, your neighbors and the City assurance that specific minimum standards are met in constructing, altering, or repairing your home by complying with the Chicago Building Code. These standards are based on well-established health, safety and environmental considerations intended to protect the integrity of the buildings, safety of inhabitants and the welfare of the public.

When Do You Need A Permit?

A permit is needed to change, replace or remove walls, columns and beams. Changes to required exits or sources of natural light and ventilation (including windows) require a permit. No permit is needed for minor repairs or decorating. However, a permit is needed for new construction, major repairs, renovations, demolitions, garages, additions, porches, decks and for the installation of new boilers, furnaces and plumbing fixtures.

Development Project Vote Slated for September Meeting

The plans for a development located at 3913 N. Ashland Ave. will be presented and voted upon at the next SNA community meeting (Monday, September 16th at 7:30), so we hope you will be able to attend and voice your opinion. The developer, Attila Demeter, will present his proposal and answer questions about the 3 new townhouses he would like to build behind an existing 2 unit building. The proposal requests are the following:

1. A variation to reduce the rear yard.
2. A special use to permit garages on the ground level. (The property is zoned B-2 which requires a business use on the ground floor).

During the meeting, the SNA Planning and Development committee will make a recommendation to the community in favor of, or against, the proposal. As representatives of the community, residents (within SNA boundaries) who are present at the meeting will then vote on the proposal. If you wish to vote, please bring a picture ID to verify your address within SNA boundaries.

New Schedule for 2003 Community Meetings

Community meetings for next year will be held QUARTERLY instead of bimonthly. They will still be held on the 3rd Monday of the month, but the months will be January, April, July and October. (These dates are subject to change if they conflict with a national or religious holiday.)

We plan to continue to keep the community as informed and involved as possible in the issues that impact our neighborhood. We simply would like to use different means of doing this, such as sending email updates, posting notices in our kiosk, and building an informative website. We know your time is valuable, and we would like to minimize the number of times we ask you to attend meetings.
